

TERMS AND CONDITIONS

Information on how to enter and prize details form part of these Terms and Conditions. Participation in this competition is deemed acceptance of these Terms and Conditions.

PROMOTERS

DURATION

The competition commences at **12:00am (AEST) on Monday 3 November 2025**, and closes at **12:00pm (AEST) on Friday 5 December 2025** ("Competition Period").

ELIGIBILITY TO ENTER

Entry is only open to Australian residents aged 18 years or over and who, at the time of entry:

- Reside in Australia;
- Hold Australian citizenship or permanent residency;
- Have a valid email address; and
- Meet the method of entry requirements outlined below.

Employees, directors, officers, and their immediate families of either the **Promoter (Tasmania Basketball Pty Ltd)** or the **Co-Promoter (MyState Bank Limited)**, or of any agencies or contractors directly associated with this Competition, are ineligible to enter.
