

## **TERMS AND CONDITIONS**

## MyState Bank 'All Star Green Room' Competition

Information on how to enter and prize details form part of these Terms and Conditions. Participation in this competition is deemed acceptance of these Terms and Conditions.

## **PROMOTER**

#### **DURATION**

The competition commences on 12:00am (AEST) on **Thursday 18<sup>th</sup> September 2025**, and closes at 12:00pm (AEST) on **Wednesday 18<sup>th</sup> February 2026** ("the Competition Period").

## **ELIGIBILITY TO ENTER**

Entry is open to Australian residents aged 18 years or over and who, at the time of entry:

- Reside in Australia;
- Hold Australian citizenship or permanent residency;
- Have a valid email address; and
- Meet the method of entry requirements outlined below.

Employees, directors, officers, and their immediate families of the **Promoter (MyState Bank Limited)**, or of any agencies or contractors directly associated with this Competition, are ineligible to enter.

For the purpose of these Terms, "immediate family" includes a spouse (including de facto), parent, child, sibling, grandparent, grandchild, or any person residing in the same household.

- 1. Attend a Tasmania JackJumpers Home Game at MyState Bank Arena (MSBA): Hold a valid ticket to attend a regular season Tasmania JackJumpers game.

- 3. **Automatic Entry:** Each eligible transaction automatically counts as one entry into the prize draw for the next regular season home game at MSBA (see 'Draw Schedule').
