

MyState Bank Glide \$100 Reward Offer Terms and Conditions

1. Eligibility

- a) This offer is available to customers who joined MyState Bank for the first time from 3 December 2025 and opened a Hello Saver account.
- b) The offer is available for first 1,350 customers. This offer is exclusively available to recipients of a direct invitation from MyState Bank via email and is non-transferable.
- c) To be eligible to receive the Reward, customers must:
 - Be Australian residents and aged 18 years or over
 - Complete 60 or more *Eligible Transactions* using their MyState Visa Debit card that is linked to their first opened Glide or Basic account between 1 April and 30 June 2026 (Promotion Period).
 - Have an open Hello Saver account at the time the *Reward* is paid.
 - Have an open Glide or Basic account and an active linked MyState Visa Debit card at the time the *Reward* is paid.
 - Must be opted into receiving marketing messages.
 - Employees of the Promoter, including Auswide Bank, Selfco and TPT Wealth are ineligible to enter.

2. Promotional Period

The promotional period commences at 12:01am AEDT on 1 April 2026 and closes at 5:00 pm AEST on 30 June 2026.

3. Reward Details

Eligible customers who meet the conditions outlined in Clause 1 will receive a \$100 Reward, which will be deposited into their MyState Bank Glide transaction account by 31 July 2026.

4. Eligible Transactions

- a) An Eligible Transaction is a settled transaction made using the MyState Visa

Debit Card linked to the first opened Glide or Basic account opened since 3 December 2025.

b) Transactions must be settled (not pending) by 5.00pm AEST on 30 June 2026 to qualify.

c) The following transactions will not count toward the 60 eligible transactions:

- Cash withdrawals or cash advances.
- BPAY transactions.
- Transfers between MyState Bank accounts.
- Payments to financial institutions, including mortgage repayments, personal loan repayments, and credit card payments.

5. Reward Payment

a) The \$100 Reward will be deposited into the eligible customer's MyState Bank Glide or Basic account by 31 July 2026.

b) If the eligible customer's Glide or Basic account is closed or inactive at the time of payment, the Reward will be forfeited.

c) If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.

6. General Conditions

a) This Reward is limited to one AUD\$100 Reward per customer and limited to one payment on the first eligible account. Joint account holders will only be eligible for one Reward.

b) The Promoter reserves the right to verify the eligibility of customers and transactions.

c) The Promoter reserves the right to disqualify any customer who tampers with the promotion or breaches these Terms and Conditions.

d) The Promoter reserves the right to modify, suspend, or terminate this promotion at any time without notice.

e) If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable

control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.

f) The use of any automated software or any other mechanical or electronic means that allows an entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that entrant invalid.

7. Disputes

In the event of a dispute regarding eligibility or qualifying transactions, the Promoter's decision will be final, and no correspondence will be entered into.
