

## **TERMS AND CONDITIONS**

### **MyState Bank Community Choice Award – Voting Prizes (“Competition”)**

Information on how to enter and prize details form part of these Terms and Conditions. Participation in this Competition is deemed acceptance of these Terms and Conditions.

### **PROMOTER**

The promoter of this Competition is:

### **DURATION**

The competition commences at **12:00am (AEST)** on **Monday 22 June 2026**, and closes at **5:00pm (AEST)** on **Monday 29 June 2026** (“Competition Period”).

### **ELIGIBILITY TO ENTER**

Entry is only open to Tasmanian residents aged 18 years or over and who, at the time of entry:

- reside in Tasmania, Australia;
- have a valid email address; and
- meet the method of entry requirements outlined below.

Employees, directors, officers, and their immediate families of MyState, or of any agencies or contractors directly associated with this Competition, are ineligible to enter.

For the purpose of these Terms, “immediate family” includes a spouse (including de facto), parent, child, sibling, grandparent, grandchild, or any person residing in the same household.

## **METHOD OF ENTRY**

To enter the Competition during the Competition Period, eligible participants must:

1. Vote in the Community Choice Award hosted by MyState via an online form;
2. Submit their first name, surname name, and email address and any additional questions via the voting form.

Entry is free and no purchase or payment is required to enter or win.

Voting is not a game of skill and has no bearing on the chance of winning a prize.

All valid entries received will be entered into a random draw as outlined in the Draw Schedule. One entry per person is permitted. Each valid entry has an equal chance of winning a prize. Entries generated by automated means, third parties, or otherwise deemed invalid by MyState may be disqualified.
