Terms and Conditions of Entry

CONDITIONS - PARTICPATION

1. This competition ("Competition") is conducted by MyState Bank Limited (MyState Bank) ABN 89 067 729 195 AFSL 240896 a wholly owned subsidiary of MyState Limited ABN 26 133 623 962 ("Promoter").
2. Entry to the Competition constitutes acceptance of these conditions. All entry instructions and prize information published by the Promoter form part of these conditions.
3. The Competition commences at 9:00am AEST on Friday 01 October 2021 and closes at 5:00pm AEDT on Friday 29 October 2021 ("Promotion Period").
4. The Competition is only open to Eligible Entrants. An "Eligible Entrant" is an individual who: (i) is a Tasmanian resident; and (ii) is over the age of 16 years; and (iii) has their 'pay' going into their MyState Bank transaction account prior to the Promotion Period and; (iv) who completes and submits an entry form in a MyState Bank branch (providing a valid name, email, contact phone number and reason they love being a MyState Bank customer), within the Promotion Period and; (v) who is a current customer at the time of the prize draw.
5. Any reference to 'Pay' in this competition refers to a regular monthly deposit of at least \$1,500, into a MyState Bank transaction account, each month, for at least the two consecutive months prior to the competition ((July 2021 and August 2021) \$3,000 in total).

HOW TO ENTER

7. To be eligible to enter the Competition, Eligible Entrants must:
8. Complete and submit an entry form at any of the MyState Bank branches, within the Promotion Period, if they are an 'Eligible Entrant' as set out in condition 4.
9. For the avoidance of doubt, multiple entries at different branches will be excluded from the Promotion.

ENTRY GENERAL

10. Employees and directors of the Promoter and its related companies, their immediate families, and retailers, suppliers and agencies associated with the Promotion are ineligible to be Entrants.
11. Entries are deemed to be received at the time of receipt into the Promoter's database. The Promoter is not responsible for any delay in, or failure of, transmission which causes an entry not to be received within the Promotion Period. Incomplete, indecipherable or illegible Entries will be deemed invalid. Eligibility is at the sole discretion of the promoter.
12. All entries to the Competition may be subject to verification by the Promoter.
13. 15. An entry by more than one person (i.e. a joint entry) is considered as one entry in the name of the first account holder.
