## Terms and conditions of entry

### **Competition Schedule**

**Competition type:** Game of skill

**Competition date period:** July 1 2022 – December 31 2022

**Prizes per draw:** 3

**Prize type:** \$500 Gift Card

### **Entry Requirements**

**Eligible entrants:** Entrants must be invited to partake in a Shape MyState survey and be aged 18 or older.

#### **Ineligible entrants:**

- Employees and contractors of MyState and immediate family members of employees and contractors
- Employees and contractors of the agencies or companies associated with the competition
- The Judges
- Customers under the age of 18

### **How to enter:**

During each competition period, the entrant must:

1. Receive the 'competition invite' email from MyState
2. Follow the URL/Link to the Shape MyState competition survey
3. Fully complete all the survey questions and answer the promotion question. Each survey will have its own unique promotion question.
4. Submit the entry by pressing Finish. Entries must be entrant's original work.

#### **Maximum number of entries per draw**

Maximum of one entry per survey completed.

#### **Method for choosing the winners**

All valid entries will be judged on quality of information, thoughtfulness and originality of response (the 'Judging Criteria') as determined by MyState Bank's Head of Innovation & Insights and the Manager of Customer Analytics ('the Judges').

Based off the judging criteria, the Judges will select three (3) winners to receive 1 gift card each.

### **Terms and Conditions of Entry**

1. These Conditions of Entry must be read together with the Schedule. By entering, entrants accept these conditions.
2. Entry is open to residents of Australia who comply with the Entry Requirements. Entries submitted by Ineligible Entrants are not accepted.
3. The competition will be run during the Competition Period only, as outlined in the competition schedule
4. The Prize is not transferable or exchangeable and cannot be redeemed for cash. If a winner does not take a part of the Prize at the time set by MyState, the winner will forfeit that part. MyState accepts no responsibility for changes in Prize value. If a Prize is unavailable, MyState will substitute it for one of equal or greater value.

6. Entrants may only submit one entry per survey submitted.
7. All valid entries will be entered into the competition. Entries must be received during the Competition Period. MyState has no control over telecommunications networks and accepts no responsibility for problems associated with them. Entries are deemed received at the time of receipt into MyState's database, not at the time of transmission. Entries submitted using any form of automated entry device or software are ineligible. Entries not fully complying with these Conditions of Entry will be deemed invalid. MyState accepts no responsibility for late, lost, incomplete, delayed, corrupted, illegible or misdirected entries whether due to error, omission, alteration, deletion, destruction, transmission interruption, tampering, theft, destruction failure or otherwise.
8. The best valid entry as determined by the judges according to the Entry Criteria will win the Prize described in the Schedule. The Total Prize Pool is set out in the Schedule.
