

## **MyState Bank 'Chance to Win A Weber Q® BBQ'.**

### **Conditions of Entry**

#### **CONDITIONS - PARTICPATION**

1. This competition ("Competition") is conducted by MyState Bank Limited (MyState Bank) ABN 89 067 729 195 AFSL 240896 a wholly owned subsidiary of MyState Limited ABN 26 133 623 962 ("Promoter").
2. Insurance issued by Insurance Australia Limited ABN 11 000 016 722 trading as CGU Insurance (CGU) of Tower 2, 201 Sussex Street, Sydney, NSW.
3. Entry to the Competition constitutes acceptance of these conditions. All entry instructions and prize information published by the Promoter form part of these conditions.
4. The Competition commences at 9:00am AEDT on Monday 16 November 2020 and closes at 5:00pm AEDT on Friday 11 December 2020 ("Promotion Period").
5. The Competition is only open to Eligible Entrants. An "Eligible Entrant" is an individual who: (i) is a Tasmanian or Queensland resident; and (ii) is over the age of 18 years; and (iii) who purchases an Eligible Insurance Policy through MyState Bank within the Promotion Period; and (iv) this policy is still active and meets competition eligibility criteria at the time of the Prize Draw.

To be eligible the Eligible Insurance Policy must be; paid in full (or in the case of pay by the month policies, the first instalment payment must be received) and; outside of the cooling off period and; active at the time of Prize Draw. The issue of an Eligible Insurance Policy is subject to CGU's underwriting guidelines.

9. An 'Eligible Insurance Policy' is a new CGU:

#### **ENTRY GENERAL**

13.
